### MATTERS RELATED TO RIGHT TO INFORMATION ACT

#### 1. Particulars of its organization, functions and duties

ICAR-NINFET was initially set up as Indian Central Jute Committee, Government of India on the recommendation of the Royal Commission on Agriculture in 1936 at Calcutta. Then it was officially established as a research institute on January 3, 1938 by Lord Linlithgow, the then Viceroy and Governor-General of India.

In 1965, the institute became a constituent unit under the centralized administrative control of the Indian Council of Agricultural Research (ICAR), New Delhi and named as Jute Technological Research Laboratory (JTRL). JTRL had prospered with multifarious dimensions and developed many indigenous technologies for jute as well as for allied fibres. In reorganization of R&D activities, ICAR had renamed the institute as "National Institute of Research on Jute and Allied Fibre Technology (NIRJAFT)" in 1998.

Being a lead research institute associated with knowledge transfer and economic development activities for all-natural fibres, the council promoted the institute to work continuously in the area of various natural fibres and accordingly institute renamed as ICAR-National Institute of Natural Fibre Engineering and Technology (ICAR-NINFET) in 2019.

The institute is located (Latitude: 22°28'50.8" N and Longitude: 88°21'10.2" E) on the southern fringe of the metropolis of Kolkata known as Tollygunge with a total plot area measuring around 17,628.67 m<sup>2</sup> in which the laboratory campus covers 3,957m<sup>2</sup>. The institute is having adequate infrastructure of modern laboratories equipped with sophisticated instruments, equipment, machinery, workshop, library, computer cell etc, along with adjacent campus of staff quarters and guest house. Besides, two sheds of pilot plant have been constructed for conducting pilot scale trials on the technologies developed.

Institute is carrying basic and applied researches related to post harvest processes of natural fibres such as Jute, Mesta, linseed/flax, sisal, ramie, banana, Sunnhemp, pineapple leaf, dhaincha, coconut, yak hair, wool, silk and other lesser-known plant fibres. Institute have formulated and proposed multidisciplinary research programs in the forthcoming five-year plan 2020-2025 in the thrust areas

- (a) Instrumentation and value addition in natural fibres
- (b) Quality improvement, specialty textiles and value chain
- (c) Environmental sustainability with special reference to natural fibres
- (d) Capacity building and dissemination of technologies.

### The R&D programmes of the institute are implemented through the following four divisions and one unit:

i. Quality Evaluation & Improvement Division

- ii. Mechanical Processing Division
- iii. Chemical & Bio-chemical Processing Division
- iv. Transfer of Technology Division
- v. Research & Development Unit

#### Mandate

- Basic and strategic research on processing jute & allied fibres and their agroresidues, development of value-added products and quality assessment.
- Skill development and business incubation service on jute and allied fibre technologies

### 2. The powers and duties of its officers and employees

Powers of the Director of the Institute shall exercise all the powers of the Head of the Department for the purpose of various Rules and Regulations of the Government of India, as amended from time to time and applicable *mutatis-mutandis* to the Society. In addition, the Directors of the Institute/ Laboratories shall exercise such powers for the functioning as are delegated to them by the Governing Body or any authority of the ICAR. The powers delegated to the Directors of Research Institutes are detailed in Schedule II. The powers detailed in this schedule however do not in any way restrict their powers as enjoyed by them as Head of the Department. The Governing Body also delegates same powers to the Institute Management Committee, the Director is the ex-officio Chairman of the committee.

**Schedule III** Powers delegated to the Directors of Research Institutes/Laboratories through Schedule-II of "Delegation of Powers in Indian Council of Agricultural Research" 3<sup>rd</sup> revised edition updated upto March, 2023. The Schedule III at of the said document enumerates delegation of powers to the Institute Management Committee of the Institute.

### 3. The procedure followed in the decision-making process, including channels of supervision and accountability

The Director is assisted in the execution and implementation of various programmes by four Divisional Heads viz. Quality Evaluation & Improvement Division, Mechanical Processing Division, Chemical & Bio-chemical Processing Division and Transfer of Technology Division and Units like Research & Development Unit, Utility Cell, Agricultural Knowledge Management unit (AKMU), Administrative Officer, and Finance and Accounts Officer of the institute provide the needed support. The Institute Management Committee (IMC) guides and supports the Director by periodic review of programmes and approval of investments in new areas of research and policy making, training programmes, workshops and seminars. The Research Advisory Committee (RAC) and Staff Research Council (SRC) provide broad guidelines and assist in developing and implementing specific research.

#### 4. The norms set by it for the discharge of its functions

The norms are set by the ICAR Headquarters, New Delhi. The various functions carried out by the Academy are indicated in the mission, mandate, and objectives of the Academy, outlined in the section (i) on "The particulars of organization, functions, and duties of the NINFET".

## 5. The rules, regulations, instructions manuals and records, held by it or under its control

ICAR-National Institute of Natural Fibre Engineering and Technology is a Unit of ICAR, New Delhi. ICAR follows GOI rules *mutatis mutandis*, besides Agricultural Research Service rules, Technical Service Rules specially designed for Scientists and Technical personnel in ICAR. The Academy follows the rules, regulation, and instructions as followed by ICAR, and as indicated in the manuals and records of ICAR, New Delhi.
